







V4 Training for Research Project Managers

Brussels, 29 - 31 March 2023

The *V4 Training for Research Project Managers* is an intensive capacity-building event that aims to raise awareness of political contexts of the EU's research and innovation programmes and initiatives with a special focus on the EU Framework Programmes for R&I. It targets a community of research project managers (RPMs), understood broadly as R&I support personnel of both public and private organisations involved in the EU research and/or innovation projects – project managers, coordinators, project (support) officers etc. Organised twice a year by R&I liaison offices of the V4 countries in Brussels, the main purpose of the training is to increase the professional capacity of its participants by:

- providing targeted information about the EU policies that have an impact on their work
- enhancing their **networks** and networking skills
- creating opportunities to learn from best practices of other organisations

The programme of the 2023 spring edition is divided into three days and consists of presentations and interactive sessions. Each presentation slot will include time for questions. During the interactive parts, participants will have opportunities to network, share experience and discuss best practices within their institutions.

12:50 – 13:35 ERA Policy Agenda

This session will give a short overview of the renewal of the European Research Area (ERA) and the most relevant actions under the ERA roadmap 2022-2024. The Council Conclusions on future governance of the ERA were adopted in November 2021 with twenty ERA actions. Up to now Member States committed to the implementation of 17 actions, many of which are relevant for research project managers (e.g. strategic capacity of public RPOs/RFOs, strengthening research careers, open sharing of knowledge, gender equality and inclusiveness and empowering higher education institutions).

Communication is crucial during networking and brokerage/matchmaking events when participants have usually only a few minutes to present a profile of their institution and its strategic research priorities. Such events provide an excellent occasion not only for researchers but also for project managers to liaise and develop partnerships, thus increasing their opportunities to be taken on board in project consortia. Such events also allow institutions and/or their research networks to be more visible to the scientific community.

Preparation for the session: Participants should come prepared to present their institution's main research directions (i.e. at the level of team / institution / faculty) in 2 minutes (without the aid of PowerPoint). While preparing the presentation, please have in mind the following concept: You are at a networking reception or at a brokerage event. You seek to collaborate with another university or company and

you have only 2 minutes to "sell" your institution and researchers and to show to a potential counterpart that you are a solid partner for a cooperation.

09:05 – 10:05 Online tools for and about Horizon Europe projects

Tools like Horizon Dashboard, F&T Portal, CORDIS, Horizon Research Booster, and Horizon Results Platform are being used by project managers for many a purpose, including administration of the EU-funded projects, the research organisation's self-assessment, and increasing visibility and valorization of the managed projects' results. A selection of the most useful available tools will be presented followed by a workshop-like showcase of Horizon Dashboard, CORDIS and F&T Portal functionalities that will bring out early statistical data on V4 participation in Horizon Europe.

Open Science is the modus operandi in Horizon Europe which affects provisions such as those regarding publication, data management and citizen engagement. Apart from a general introduction to the EC's Open Science policies and initiatives including the one on reforming research assessment this session will focus on Horizon Europe requirements for data management and on the publishing platform Open Research Europe.

The presentation shares good examples of universities, how they support the participation of scientists in European research programmes. 12:50 – 14:10 Evaluation in Horizon Europe

The session will provide participants with a solid understanding of the evaluation process and scoring system in Horizon Europe so that they could better address evaluation criteria when applying to calls for proposals. It will explain the role of all actors involved in the process and give advice on what to watch out for in terms of Horizon Europe novelties. Through an insider's view it will also provide tips for how to gain competitive advantage in the evaluation and how to read the evaluators' feedback for a successful resubmission.

The session will provide an insight into the lump sums funding in Horizon Europe. The European Commission is gradually shifting from actual cost proposals to Lump Sum proposals. In 2023/24 more than 30% of the call topics in Horizon Europe Pillar 2 will be funded under Lump Sum conditions. Therefore, chances are high that you will participate in a Lump Sum proposal as either coordinator or partner. What will be the impact on your proposals/projects and how to strike a balance between asking too much and too little?

Good practices that help professionals in different sectors to manage projects effectively and to deliver results have been compiled in various project management methodologies. For use in the specific environment of EU institutions the European Commission developed the PM2 methodology that is widely applied by its staff and project officers. It is also promoted among potential beneficiaries for effective management of EU funded projects. Understanding its language and how it translates to Horizon projects holds, therefore, many advantages. This session will provide a basic introduction to PM2 followed by an interactive exercise.
